## **Council/Mayor Comments**

- 1. Councilmember Kostukovich: shared West Shore Bureau of Fire announced at their meeting a future increase in fire tax as they need to purchase a pumper truck at approximately \$1.1 million dollars in addition to the \$176k just spent on the required radio purchases and upgrades.
- 2. Councilmember Koontz: Noted:
  - **a.** He attended the Cumberland County Planning Commission meeting regarding the rezoning of Plum Street. With the approval from Cumberland County, this change will go back to the Lemoyne Borough Planning Commission meeting in March to then have their recommendations to Council by the April 4th Work Session.
  - **b.** The Electric Vehicle Charging Station draft ordinance will also be discussed at the March 12<sup>th</sup> Lemoyne Borough Planning Commission meeting.
- **3. Mayor Salkowski:** shared the date of the Community Clean-up Day will be April 20, 2024 check the Borough Facebook page and website for more details.
- 4. Chief Minimum shared:
  - a. In continuance of gifts given to a family WSRPD had adopted for Christmas, Chief Minium, Assistant Chief Friel and officers hosted the children to pizza and games while their parents enjoyed their gift of a date night.
  - b. Statistics discussed at the Police Commission meeting, noting significantly lower cases of overdoses and crimes against people and property as well as stating that 78% of arrests are non-residents.
