

**LEMOYNE BOROUGH COUNCIL  
PARKS AND RECREATION COMMITTEE  
SEPTEMBER 16, 2009**

1. Call to Order...The Parks and Recreation Committee meeting, of the Lemoyne Borough Council, was called to order on Wednesday, September 16, 2009, at 6:00 P.M., at the Lemoyne Municipal Building, 510 Herman Avenue, Lemoyne, PA with Jodie Ruediger presiding.

2. Roll Call...Present at roll call was Jodie Ruediger, Chairperson and Lori Hedegus. Absent was Sue West.

Also present were John Paden, Robert Ihlein, and Roi Basptiste.

3. Pool Management:

The fee for the West Shore Recreation will be the amount of \$8,719. A discussion was held on the West Shore Recreation or the West Shore Y to be the management of the pool for the year. Mr. Ihlein was instructed to come up with a RFP for the upcoming pool programs and to promote membership. Mrs. Ruediger made a motion for Mr. Ihlein to develop a RFP for the swimming pool. Ms. Hedegus seconds the motion. All were in favor.

4. Facility Fees:

The committee discussed the park pavilions rental fees. The following fees were recommended by the committee: \$50 per day per resident, non-profit, business and \$100. Per individuals, non-profit, and business located outside of the Borough.

The committee discussed the community room fees. The following fees will be \$20 per hour, \$50. for half a day (4 hours), and \$100 for all day. These amounts are for residents, non-profits, and business within the Borough lines and \$40.Per hour, \$100. for half a day (4 hours), \$200. for all day non-residents, non-profits, and business located outside of the Borough lines. The removal of trash from the community room will be taken to the Borough owned dumpster.

The exceptions from the charges will be the Lemoyne Senior Citizens Club, Lions Club, Civic Club, and American Can.

Ms. Hedegus suggested granting a 1 free use per year to non-profits in or outside of the Borough. The groups must show non-profit status. Any group providing a free public service or events open to the public.

Ms. Hedegus made a motion to approve the fees for the parks pavilions and community room. Mrs. Ruediger seconds the motion. All were in favor.

5. Copper Ridge Recreational Fund:

Mr. Paden will get prices on two swings and four benches for the Riverfront Park. This will be presented to the council at the October's meeting. Mrs. Ruediger mad a motion to have Mr. Paden to get prices on the above equipment. Ms. Hedegus seconds the motion. All were in favor.

6. Pool Fence:

Mr. Paden suggested placing privacy slats in the rear fence at the swimming pool. This will extend the rear fence back approximately ten more feet. The cost of the slats is approximately \$1,500. The borough crew will install the slats. Mrs. Ruediger made a motion to purchase the slats for the pool fence. Ms. Hedegus seconds the motion. All were in favor.

7. Adjournment: 7:50 P.M. There being no further business Mrs. Ruediger declared the meeting adjourned.
